City Bridge Foundation Applying for Funding



Vision

For London to be a city where all individuals and communities can thrive, especially those experiencing disadvantage and marginalisation.

Mission

To reduce inequality and grow stronger, more resilient and thriving communities for a London that serves everyone.

Values

We aim to be: Progressive; Adaptive; Collaborative; Inclusive; Environmentally Responsible; and Representative.



Decision Making Process



- 6 months decision time (main grants programme)
- Online application form and supporting documents
- Full review by Funding Manager
- Assessment visit or call if this is not possible
- Charities Finance Team review
- Decision
- Public committee meetings



What you need to provide with your application



- Your governing document (i.e. your constitution)
- Most recent signed accounts
- (We will likely ask that you provide us with two further sets of financial information after you apply, e.g. draft accounts, management accounts, budget, or forecast)
- Safeguarding policy
- Fully costed budget
- Impact measurement framework



Who we fund



- Registered charities
- Registered Community Interest Companies (CICs)
- Registered Charitable Incorporate Organisations (CIOs)
- Charitable companies
- Exempt or excepted charities
- Registered charitable industrial and provident societies or charitable Community Benefit Societies (Bencoms)
- Constituted voluntary organisations (this is specific to the Small Grants programme, Constituted voluntary organisations are not eligible for other CBF funding)



Who we don't fund



- Party political organisations
- Charities registered outside the UK
- Individuals
- Schools, PTAs, other educational establishments
- Hospitals and primary healthcare providers
- Statutory bodies

Environment and sustainability: creating a greener London



Revenue funding: making London a greener city for all

We want to fund local projects that take an equitable approach to mitigating and/or adapting to climate change. We encourage applications both from organisations that already actively focus on climate and nature and those that have not previously seen environmental action as a priority.

Grant details

Deadline: Applications accepted on a rolling basis

Funding length: Up to 5 years

Funding size: There is no minimum or maximum limit to how much we will give, however we never give revenue funding exceeding 50% of the applicants turnover/income in any one year

Examples of projects we can fund include work that:

- sets out to reduce London's emissions
- protects, manages, expands or enriches London's green spaces
- tackles poor air quality
- prevents and prepares for impacts of climate change such as flood and/or drought or heatwaves
- promote biodiversity
- increase access to growing spaces



How much can you apply for?



- "Full cost recovery" we will contribute to your overheads and core costs as part of project funding
- Up to 5 years' continuous funding
- A revenue grant can be up to 50% of an organisation's income as of latest signed accounts
- Minimum of the Real London Living Wage (currently £13.15/hr) for salaries
- Up to 1 FTE post for salary costs
- We can be the sole funder of a project or contribute to larger work
- Average grant size available on website



Environment and sustainability: creating a greener London



Eco Audits

Eco Audits set out ways organisations can be more sustainable and reduce their carbon footprint. They are free and available to all eligible organisations wherever the building is owned or with a lease over two years.

Two-part visit by a specialist Eco Auditors consisting of an initial audit and a follow-up visit. Investigates all aspects of the organisation's ways of working. Auditors make recommendations on ways to reduce environmental impact returning after 1 year to review what's been implemented and to measure any savings.

Grant details

Deadline: Applications accepted on a rolling basis **Funding size:** External auditors carry out the audit and are paid directly, the average award is £

Applicants need to demonstrate its building and activities benefit the wider community and do not exclusively advance the promotion of any of specific religion. The building doesn't have to be open to the public, as long as the work of the organisation benefits the wider community.



Environment and sustainability: creating a greener London



Capital funding for building works

Funds to carry out the building work recommend by the eco audit where organisations own the building or have a lease of at least 10 years.

Grant details

Open to: Organisations in receipt of an Eco Audit from one of our approved consultants prepared in the last three years, or applicants in receipt of a Refresher Eco Audit. Organisations already holding one of our mainstream grants are not eligible to apply for capital funding.

Deadline: Applications accepted on a rolling basis

Funding size: Up to £150,000

We can only fund work where the total refurbishment costs do not exceed £15 million.

Works can include (but not necessarily limited to):

- Insulation
- solar panels
- heat pumps
- on-site biodiversity schemes
- energy efficient lighting systems
